




Nr of mobile sites




Origin of the whole blood donations






Age of donors




Donor examination








University Hospital Innsbruck

What is the legal background?



Austrian Blood Safety Act 1999:

- Translates the EU-Directives
- Regulates
 - generally blood donation, including all forms of preparative apheresis, too.
 - management, licensing, minimal setting of donation sites, quality assurance and documentation
 - requirements concerning donor acceptance, donor selection, donor safety and identification.
- **Blood Donor Ordinance:**
 - Donor acceptance and examination,
 - medical history,
 - deferrals policy (temporarily, permanently), donation volumes, donation frequency and pre-donation testing
 - screening tests and
 - post-donation care are regulated in detail.



Pharmaceutical Act 1983

- **Blood, blood components and derivatives are pharmaceuticals** if they are used for medical purposes and therefore nearly all products for transfusion are subject to the pharmaceutical act and corresponding ordinances.
- This law **relates to principles of good manufacturing practices (GMP)** and sets quality requirements on the production and release of pharmaceuticals.
- It also **covers haemovigilance** and the mandatory reporting of serious adverse events and reactions.
- In 1998 by decree unique criteria for donor selection and identification based on international standards, and for HIV-testing of each blood donation were defined.
- **Pharmaceutical manufacturing ordinance 2005:**
 - A thorough **interpretation of good manufacturing practices**.
 - It is nowadays the major legal document in regard to inspections and the licensing procedures.

Licensing, certification and accreditation

Must

- Blood banks need a license on the basis of the pharmaceutical law**
 - The Austrian Federal Agency for Safety in Health Care is the competent authority
 - Bi-annual inspections by Agency for Health and Food Safety (AGES)
 - Site master file is the basic document
- Blood donation sites and fixed locations are inspected by the local health departments**
- Most immunogenetic laboratories are based in BE and are accredited by the European Federation of Immunogenetics (EFI).



Voluntary

- Although certification of quality systems is not required by the specified laws and an uniform quality management system does not exist, all blood centres are **ISO 9001:2xxx** certified.
- Most quality systems are nowadays **hybrid systems of ISO 9001:2xxx and GMP**.



Tasks of blood establishments

Tasks of BE

- Service for 183 hospitals, either directly - if blood establishments are adjacent to hospitals - or indirectly by hospital blood banks
- Recruitment of donors,
- Preparation and screening of sufficient amounts of blood products for patient care in hospitals
- Compatibility testing
- Immunogenetics, genetics, immunology,
- Prenatal testing,
- Infectious disease testing
- Tissue banking and tissue engineering
- Therapeutical apheresis, immune absorption and photopheresis



Plasma for fractionation

- Vienna is the „capital of plasma fractionation“:
 - 4 Mio/27 Mio liters of plasma worldwide are fractionated in Vienna
- 18 Plasmapheresis-sites
- 2013:
 - 40000 donors
 - 547840 liter donated




Location of the plasmapheresis centres
